FORM OF MONTHLY DISTRIBUTION DATE CERTIFICATE

This Monthly Distribution Date Certificate (the "Certificate") is being provided by the Higher Education Loan Authority of the State of Missouri (the "Authority") pursuant to Section 5.04(c) of the Indenture of Trust, dated as of April 1, 2021 (the "Indenture"), between the Authority and U.S. Bank National Association, as trustee (the "Trustee"). All capitalized terms used in this Certificate and not otherwise defined shall have the same meanings as assigned to such terms in the Indenture.
