This Monthly Distribution Date Certificate (the "Certificate") is being provided by the Higher Education Loan Authority of the State of Missouri (the "Authority") pursuant to Section 5.04(c) of the Indenture of Trust, dated as of February 1, 2021 (the "Indenture"), between the Authority and U.S. Bank National Association, as trustee (the "Trustee").
